Call Meeting to Order & Approval of Minutes: Vice-Chairman Bergen:

Deputy Director's Comments: Phil Maier

D.D. Maier briefed the Board on DNR'S modified protocols during the pandemic. Staff continues to adjust and adapt to current conditions fulfilling their job duties. He reported our current Legislative package including proposed changes in law for cobia and flounder management.

Tournament Committee Report: A. Dukes

Old Business – A. Dukes:

A. <u>SC Memorial Reef /Hwy 21 Bridge Project Update:</u>

Amy briefed the Board on fundraising efforts as it is the primary issue with moving forward with the project. The Harry Hampton Board asked the GC Board to look at the Reef Fund in the GC account to assist with the project. The Memorial Reef website is up and coming and should be live by the next GC Board meeting. The Board discussed ideas to assist with fundraising. The option of naming rights for a certain monetary threshold was brought up. DNR Board Chairman Pulliam indicated that the Board would agree to that.

Chairman Mungo suggested that that the GC Board send names of potential donors to Amy and send letters out to them. He suggested starting a social media push and that the individual tournaments have a check off box on registrations for donations to the reef fund.
