energy that each of our Advisory Board of Directors (some of whom are listed above) put into overseeing the program, but also their generous individual donations that were made toward the operation of the Series. While the 2015 season was a great success, both from a fishing and operational standpoint, we cannot rest on our laurels and must once again begin fundraising. Each level of support comes with associated benefits. There are many levels at which to give; last year we had 36 donors and received contributions from \$100 to as large as \$10,000. Of course, there are varying benefits that you or your company accrue depending on the level at which you donate. First, everyone who donates a minimum of \$100 gets an invitation to the Annual Awards Reception. Those donating \$500 also get mentioned on our website and in the Awards Reception program. Those donating \$1,000 (Newsletter Sponsor) get their logo in every Newsletter, in addition to the benefits mentioned above. Those donating \$2,000 (Patron Sponsor) are also included in all Series advertising, are allowed the use of the Governor's Cup logo in their own advertising, are given the opportunity to include their company brochures in boat registration packets for all tournaments, and they receive recognition of appreciation at the Awards Reception. ## Getting prepared for your 2016 Fishing Season:

It's that time again, and we thought we would provide everyone with a brief list of some of the permits, licenses and documentation that you will/may need to have in your possession so that the boat owners, captains and crew are ready for a successful fishing season. Please Double Check Your Expiration Dates!!!



fishing trip is documented in accordance to SC law under the vessels Charter License. The vessel can only have six anglers, captain and crew on board. In addition, the owners/operators of these vessels must also possess the following two permits/licenses: \*\*

1) Purchase your Atlantic HMS Angling Permit (Recreational) or Charter/Headboat Permit - All owners/operators of vessels fishing recreationally, or owners/operators of Charter/Headboat vessels fishing for and/or retaining regulated Atlantic Highly Migratory Species (Atlantic tunas, sharks, swordfish and billfish) in the Atlantic Ocean, including the Gulf of Mexico and Caribbean Sea, must obtain an Atlantic Highly Migratory Species (HMS) permit. 2016 Atlantic HMS permits cost \$20.00, and will be valid from the date of issuance through December 31, 2016. Visit the NMFS website at <https://hmspermits.noaa.gov/> to apply for your permit.

2) Purchase your SC Saltwater Fishing License - All anglers (over age 16) must obtain a SCDNR Saltwater Recreational Fisheries License. SC Saltwater Recreational Fisheries License can be purchased at <https://dnrlicensing.sc.gov/DNRLicensingSales/SalesCategories.aspx> or call 1-866-714-3611. Be reminded that now, SC Saltwater Recreational Fishing Licenses are issued on a 365 day basis, and will expire one year from the issue date.

\*\* All Series participating vessels and recreational fishermen will at minimum need the two above mentioned permits/licenses. If you are operating a Charter/Headboat vessel, then the vessel must possess a current SCDNR Charter/Headboat license. These vessels are exempt from having anglers purchase individual saltwater fishing licenses, as long as the

3) Purchase your Dolphin Wahoo Permit - All owners/operators of Charter/Headboat vessels, are required to obtain an Atlantic Charter/Headboat Permit for Dolphin/Wahoo. The permit is \$25.00, and will be valid for one calendar year. Visit the NOAA Southeast Region website ([http://sero.nmfs.noaa.gov/operations\\_management\\_information\\_services/constituency\\_services\\_branch/permits/permit\\_apps/index.html](http://sero.nmfs.noaa.gov/operations_management_information_services/constituency_services_branch/permits/permit_apps/index.html)). Application #1 to apply for your permit.

4) Purchase your Operator Card- All owners/operators of Charter/Headboat vessels are required to obtain an operator card when fishing for Dolphin and/or Wahoo. The Operator Card fee is \$50.00, and is valid for three years. Visit the NOAA Southeast Region website ([http://sero.nmfs.noaa.gov/operations\\_management\\_information\\_services/constituency\\_services\\_branch/permits/permit\\_apps/index.html](http://sero.nmfs.noaa.gov/operations_management_information_services/constituency_services_branch/permits/permit_apps/index.html)). Application #2 to apply for your operator card.


